 - 2 planned events—no date yet (Lopez—Salon, Zetzer—6 CE). Ventura County would like to co-sponsor. Will research how co-sponsorship works with CPA.
 - Inquired about how we determine speaker fee for longer CE events. Requested support on appropriate compensation for Dr. Zetzer.
 - Dr. Megan Donahue to look into reimbursement provided in the past.
- 2 tentative events—Pacific Pride, Dr. Art Martinez, Director at Chumash Center for Native Child & Family Resilience, Tribal Law & Policy Institute (more info to follow).
