- CPA Disaster Response Network has asked Dr. Karen Lehman to present the SBCPA/CWT collaboration model as an example of **best practices** in Disaster Response at another virtual meeting on 12/18/2020.

- Provided updates re. County status: move to Purple Tier, and CA State changes in tier movement.
 - There was a change in overall procedure, that any county can be changed immediately. Businesses now only have 24 hours to comply with changes.
 - No more indoor dining, fitness and worship. Board of supervisors voted to advocate for indoor worship.
- New State Mask mandate that states you must have mask with you at all times when leave house, have on when within 6 feet of someone or anytime indoors.
- Update on highest transmission of COVID-19 through working indoors, Isla Vista, and retirees. Farm workers have decreased transmission rate.
- CoVid19 newsletter continues to be published weekly with amazing contributions from Chuck Lepkowsky.
- CWT weekly meetings, Wednesday 7:30am continuing includes updates from county OEM/PHD, and reports from various behavioral wellness/mental health organizations. It



is clear that most of our MH systems are strained and not able to meet the demand - this is why we are hoping to find providers to lead group therapies, virtually... any thoughts on how to increase our reach? - and also Betsy's suggestions on active listing of who has openings (if not already discussed)

- Member support Zoom Meetings have restarted these and expanded the times available. Brooke Sears (monthly Tuesday 8am), Megan Donahue (monthly Thursdays 7:30pm), Karen Lehman (Saturdays 9:30am)
- CWT met prior to the election, at the recommendation of Police/Sheriff/Fire Depts and OEM to organize stress relief efforts around the election. These virtual groups were provided online in both English and Spanish, and well attended
- CWT and Hospice created a "Senior Bridge" program, which connects primarily isolated Seniors with live and regular telephone check-ins throughout the holidays
- Dr. Dean Given stepped up and gave a helpful presentation for psychologists on how to support evangelical clients who may be struggling with election results this past Saturday
